I understand I will be emailed an invoice upon registration and will receive a google drive link for your account with Spirit of Dance. Spirit of Dance will regularly update payments and invoices, so you will always have access to your account balance. The invoice provided will have your full year's tuition on it.

I understand that all tuition fees are due promptly according to the payment schedule agreed upon. On the 2nd of every month, any accounts that have not made the required monthly payment will incur a \$25.00 late fee and 3% interest on the outstanding amount. This will be reflected on your google drive link.

I understand that if I am not paying in full upon registration, I will have monthly installments due, either by payment in person, e-transfer or automatic withdrawal from a credit card. First month payments are due by September 1st, 2023, and all accounts must be paid by April 1st, 2024.

I understand that the registration fee is non-refundable (\$20 per student and \$15 per any additional family member) and it is due upon registration. This fee will cover administrative fees as well as a recital t-shirt souvenir.

I understand that once the dance season has commenced, I will have 2 weeks from the start date to withdraw from a registered class to receive a refund (less the registration fee, \$15/class, plus HST). After that time, Spirit of Dance will be happy to place your child in a different class or offer a credit towards a birthday package or future tuition.

I understand any changes made to my tuition invoice after the 2-week trial period will incur a \$25.00 administration fee. ie: Changing classes, adding classes, etc.

I understand that classes will not be pro-rated. Spirit of Dance will begin its 25th Anniversary Season on September 9th, 2023, and will run until April 28th, 2024, (approximately 30 weeks of dance).

I understand that each discipline of dance will perform a routine in our year-end recital, and therefore, will have a costume that can either be purchased or fundraised. The costume invoice for pre-Competitive will be due by October 1st, 2023 and Recreational will be due by November 1st, 2023. Costume pricing will range from \$80.00-\$120.00. I will also be required to purchase tickets to the year-end show through the Thunder Bay Community Auditorium through ticket master.

I understand that I will receive a student handbook that will outline important dates and information, including recital info, photo dates, competition dates etc. I will also receive band app classroom links that I am required to join for information.

I understand that my child will need to wear the proper attire and footwear for class. (Info will be provided in the handbook.)

I understand I will receive information about the fundraising program available to our dancers and will be given an agreement form should I choose to participate. I understand that our Fundraising committee will run events and fundraisers that may require donations or volunteers and may need assistance. I understand I am not required to help, but any funds raised go towards the year-end Awards, Dinner & Dance Banquet for all students & dance equipment ie: acro mats.

To keep our Fundraising Program running smoothly and fairly for everyone, we ask that each family participating in fundraising sign this form to have it on file. Please initial each, sign and return to the studio to open your fundraising account for the season.

_____ Every September, a \$7.50 service fee will come out of your fundraising. This is to assist in covering service charges, purchasing of cheques, any bank charges associated with the fundraising account, etc. Any access at the end of the year is moved into the banquet fund.

_____ I understand I will be provided with a google drive link to track my fundraising account via email.

_____ I am aware that fundraising may only be done through my own personal Facebook/Instagram/Snapchat accounts, family, and friends or at my place of employment (should they allow). I may not post fundraising items for sale in any of the buy and sell groups on Facebook. The studio or committee members may post to raise funds for banquet or other dance related items in these groups.

_____ The fundraising committee will be prompt in posting cuts to your google drive link. Fundraisers that are instant funds (tags, etc), will be posted within 5 days of the fundraiser. Cuts from fundraisers that are orders being delivered will go in 5 days after the order has arrived. Any fundraisers that must wait for a cheque to arrive from the company will not have cuts included in your account until the cheque has been received and deposited. Please do not message any committee members asking for the cuts on the same day as the fundraiser—if you notice an amount is missing after 5 days, please inquire with a treasurer.

_____ If there is an issue regarding your balance or you feel there is an amount issue with your cuts or balance, please contact a treasurer on the committee. Please do not discuss your dispute with other parents at the studio.

_____ Fundraising balances are non-transferable. They may not be transferred between dancers, parents, or other family members. Should I leave the studio for any reason and not return for the following season, I understand that any balances in my fundraising account will not be issued back as a refund and my balance will go into the banquet account.

_____ I understand that to use my fundraising, I am required to fill out a request form and turn it into the committee or the drop box at the top of the stairs and that they must be turned in on time.

_____ All request forms to use fundraising monies will be pre-approved and signed off by the studio director before cheques are issued or turned over to the appropriate request. Any request forms turned in after a due date are subject to a \$5.00 late processing fee.

_____ If by November 1st, 50% of the tuition has not been paid to the studio, the fundraising committee reserves the right to turn your fundraising money over to the studio.

_____ Items that can and cannot be claimed by fundraising are posted at the studio on the bulletin board at the top and bottom of the stairs and are listed in your handbook. Some items you can include are tuition, costumes, competition fees, etc.

_____ Any funds raised by me while enrolled at Spirit of Dance will be held in my child's name to be used for items of my choosing from the approved list located at the studio.

_____ Tuition must be paid in full before the purchasing of banquet tickets will be allowed.

_____ I understand that if I terminate my relationship with Spirit of Dance, I forfeit any further use of fundraising immediately.

_____ I understand that event fundraisers may have additional rules/obligations that will be set prior to the event that must be always followed. Any different rules or guidelines will be posted at the announcement of the fundraiser.

_____ I understand that participating in banquet fundraisers will help keep the cost of tickets down at the end of the year. Banquet fundraisers also give the studio/committee more help to extras at banquet such as photo booths, awards and/or candy bars, etc. Banquet fundraisers will be announced on the band app regularly.

_____ All dancers participating in tag days or other public fundraising events are required to always wear SOD spirit wear or spirit t-shirts/jackets. Hair should be in a bun and tidy--You represent the studio when in the public eye and should be dressed appropriately. Before participating in Tag Day Fundraisers, you will be required to fill out the "Tag Day Contract".

_____ I give the SOD Fundraising Committee permission to send emails to the above email listed in regard to tuition, payments, fundraisers and events regarding fundraising.

_____ I understand that all fundraisers and events will be posted on the SOD Fundraising Page on the Band App as well as placed on the fundraising counter at the studio. It is my responsibility to join the band group and follow all fundraising deadlines and guidelines.
